

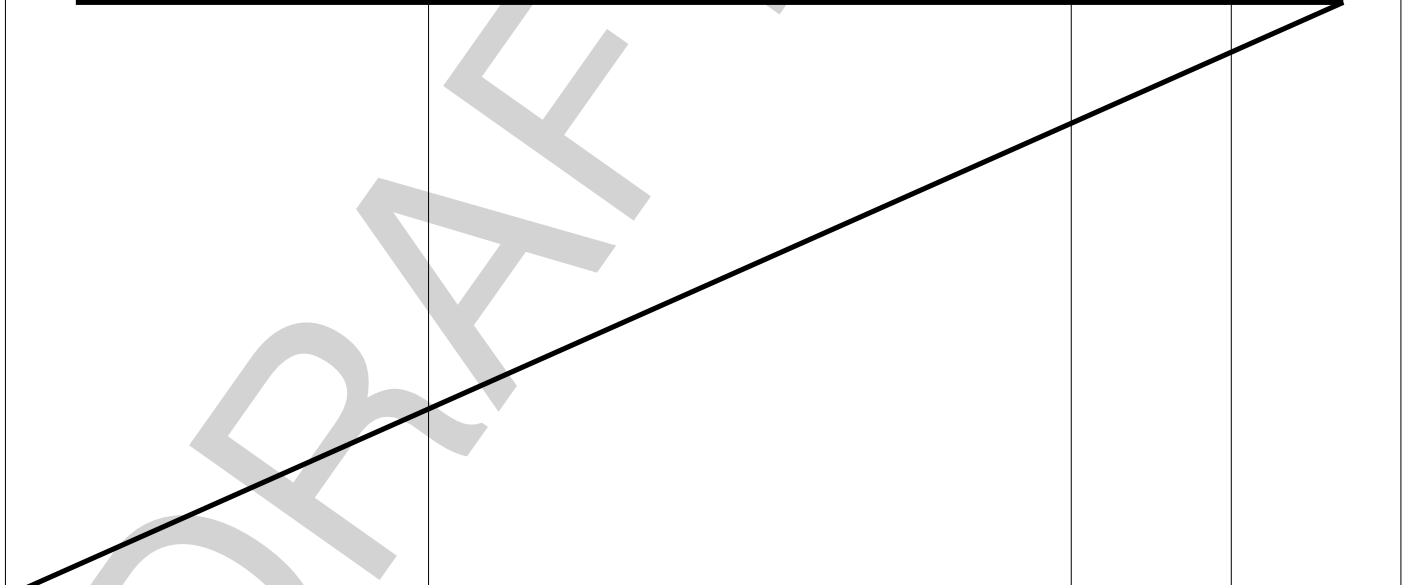

Penalties for furnishing untrue information

It is an offence under the Customs and Excise Management Act 1979, Section 167, to provide, or cause to be provided, untrue information or evidence to an officer of HM Revenue & Customs. Accordingly, any person who does so in support of an application for the issue of a movement certificate, or in the course of any subsequent verification, may be liable to penalties.

Complaints

The Adjudicator reviews complaints not settled to your satisfaction by HM Revenue & Customs. The recommendations of the Adjudicator are independent and the service is free.
