#### On to the President's Report

Moorlands Overview Speech and elections 2024

Staffordshire Moorlands Chamber **membership** currently stands at 103. This is up by 6 members compared to this time last year. It's been another challenging year for retaining members when membership can be seen as discretionary spend. However, despite these challenges, we have continued to recruit new members.

The Chamber continues to be the 'go-to' place for business advice and support in these difficult times and our levels of member engagement have increased during the year.

The **Business Start-Up Program** has supported 24 individuals with advice leading to the creation of 15 businesses in the area. Support has included workshops on business basics, cashflow forecasting and marketing as well as our One2Three Club sessions that support businesses in their first one to three years of trading.

We also continued to deliver our **Boosting Women in Business** Program to support more female entrepreneurs across Staffordshire to consider starting a business. This has provided a supportive network for female entrepreneurs to start and grow their business ideas.

We continue to work closely with **Staffordshire police.** Our Business Crime advisers have provided crime advice to nearly 650 businesses across the Moorlands area with specialist advice and support to get victims of business crime back on their feet.

The **Stoke on Trent & Staffordshire Growth Hub** also helped to support Moorland's businesses to develop and grow.

Since March 2023, the Chamber has supported **38** businesses in the Moorlands, received **117** helpline telephone calls, completed **20** Diagnostics, and made **39** referrals to partner organisations for assistance.

The **Skills Hub's** UKSPF contract began in July 2024 and has already supported over 50 local businesses through Training Needs Analysis (TNAs). TNAs offer organisations an opportunity to discuss training needs and explore funding options to support upskilling and succession planning. In addition to the tailored support that a TNA provides, businesses can also book a variety of training courses focused on digital skills, management, and net-zero initiatives. Furthermore, a grant of up to £2,000 is available to cover any raining costs not currently funded, helping businesses and employees upskill.

The International Trade Centre here at Staffordshire chambers have processed export documents to the value of £180m, so far. The International trade team continues to be incredibly busy, processing import & export customs declarations as well as regular export documents. The team is processing more declarations than other Chambers across the West Midlands and ranks as 2nd in the country. They are continuing to do well with providing training across Staffordshire.

**Events -** The wider Chambers' events team has continued to deliver a rich and diverse mix of events throughout 2024.

In the past year, Staffordshire Chambers of Commerce successfully hosted a total of 267 events, attracting an impressive 5,414 delegates. These events provided valuable opportunities for networking, learning, and collaboration among local businesses, showcasing our commitment to supporting the growth and development of the Staffordshire business community.

In Staffordshire Moorlands, we hosted 10 events, attracting 276 delegates. Events included speed networking, our quarterly Moorlands Business "Meet Up" at The Stafford Arms, and a charity football tournament.

We hope to continue to grow the numbers coming to each meeting and continuing to develop a stronger and prosperous business community in the Moorlands.

#### **Policy**

The UK went to the polls in July and whilst much of the political landscape across Staffordshire has shifted from blue to red, Dame Karen Bradley retained her Staffordshire Moorlands seat. The constituency itself has expanded and now includes the market town of Cheadle, which was previously inside the Stone constituency. We will be meeting with Dame Bradley on 15.11.2024. and look forward to a constructive discussion around the key business issues for Staffordshire Moorlands. In July, our CEO (Rachel Laver) met with Andrew Stokes, Chief Executive of the alliance authorities Staffordshire Moorlands District Council and High Peak Borough Council. Discussions focused on devolution and green infrastructure. We encouraged Mr Stokes to share good news stories with our Comms team, to highlight positive developments taking place.

Earlier in the year, we wrote to Staffs Moorlands District Council, on behalf of one of our members, to raise concerns about some of the guidance being applied in the delivery of an SME Innovation Grant, funded through the UK Shared Prosperity Fund.

These concerns related to the specification to obtain three quotes for a specific piece of work, which our members felt would be a challenge, given the nature of innovation work being delivered. The Council listened to the points raised and acknowledged the need for more clarity about the way funding programs are delivered.

We strive to serve as the voice of our members through our lobbying and representation role.
